#### **General Business**

Mr. O'Brien moved and Mr. Simmons seconded the motion to authorize and sign an Ohio Department of Job and Family Services (ODJFS) Subgrant Agreement, as requested by Children's Services, which establishes the terms, conditions and requirements governing the administration and use of the financial assistance received by or used by the Miami County Public Children Services Agency (PCSA). The Provider agrees to provide the placement and related services specified in each Individual Child Care Agreement (ICCA) for children in the care and custody of the Title IV-E Agency for the period of January 1, 2017 through December 31, 2017. The ICCA shall be consistent with current, federal, state and local laws, rules and regulations applicable to the Provider's license or certified functions and services.
