#### **RESOLUTION NO. 18-10-1284**

Mr. Simmons moved and Mr. Evans seconded the motion to authorize Britt R. Havenar, PE, PS, Chief Deputy Engineer to the Miami County Engineer, to apply to the Ohio Public Works Commission (OPWC) for financial assistance for the capital improvements to a section of Ross Road by performing an asphalt overlay from State Route 202 east to State Route 201 in Bethel Township. Further, the Board of Miami County Commissioners will enter into all agreements as may be necessary and appropriate for obtaining this financial assistance. #### **RESOLUTION NO. 18-10-1285**

Mr. Evans moved and Mr. Simmons seconded the motion to authorize and enter into a Contract with the Village of Pleasant Hill ("Village") and the Sheriff of Miami County for the purpose of providing police protection to the Village of Pleasant Hill, Ohio to provide twenty-four (24) hour a week police protection, seven (7) days per week. The Village agrees to pay to Miami County the sum of \$33,284.48 for the term of January 1, 2019 through December 31, 2019. ## **RESOLUTION NO. 18-10-1286**

Mr. Simmons moved and Mr. Evans seconded the motion to amend Resolution No. 18-08-1045 and authorize West Central Juvenile Detention employee, Karen Eisnaugle, to attend the Serve Safe Class offered by Upper Valley CTS in Piqua, Ohio on the dates of October 15, 16, 22 and 23 2018 instead of on August 21, 23, 28 and 30 2018 as previously approved. Upper Valley CTC was unable to hold the August class originally scheduled because not enough people registered. Said Statements of Qualifications will be received by the Board of Miami County Commissioners until 1:35 p.m. on Thursday, November 1, 2018. Further authorize the attached legal notice to be placed in the Dayton Daily News on Sunday, October 14, 2018, as well as on the County website.
