Mr. O'Brien moved and Mr. Cultice seconded the motion to hereby approve/sign the attached Enterprise Zone Agreement #35 with Clopay Building Products Company, Inc., pursuant to ORC Section 5709.632 and in conformance with the format required under Section 5709.631, for exemption of \$30,000,000 for 100% real and tangible property tax abatement for 15 years on the basis that Clopay Building Products Company, Inc. invests additional capital (consisting of the expansion of its facility located at 1400 West Market Street, Troy, Ohio) of \$30,000,000 to expand in Troy and will increase its employment commitment from 918 to 1,123 employees. The Company will continue to pay various other taxes and real estate taxes on the land and on the previously existing building value. On July 6, 2015, by Resolution 15-071, the Board of Education of the Troy City School District supported said Enterprise Zone Application for full enterprise zone tax abatement benefits and exempts this Agreement from the City's obligation to make payments to the School District in connection with the Project pursuant to Section 5709.82 ORC and/or the Enterprise Zone Compensation Agreement dated December 9, 1996 by and between the City and the School District. On July 6, 2015, by Resolution R-32-2015, the Council of the City of Troy approved the requested Enterprise Zone Agreement.
